Section 4: First-aid Measures

Inhalation

Rescuers should put on appropriate protective gear. Remove from area of exposure. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Keep victim warm. Get immediate medical attention. To prevent aspiration, keep head below knees.

Eye Contact

Immediately flush eyes with water. Flush eyes with water for a minimum of 15 minutes, occasionally lifting and lowering upper lids. Get medical attention promptly.

Skin Contact

Remove contaminated clothing. Wash skin with soap and water. Get medical attention. Wash clothing separately and clean shoes before reuse.

Ingestion

If swallowed, do NOT induce vomiting. Give victim a glass of water. Call a physician or poison control center immediately. Never give anything by mouth to an unconscious person.
